- 4. The perusal of the case reveals that the PIO has not provided complete information to the appellant after the lapse of the 11 months period. Therefore, <u>SHOW CAUSE NOTICE</u> under Section 20(1) of the RTI Act is issued to the Public Information Officer O/o Village Development Officer, Gram Panchayat, Farid Khera, Block Lambi, Sri Muktsar Sahib to explain as to why penalty should not be imposed upon him for willful delay/denial in supplying the information to the RTI applicant and why the compensation be not awarded to the appellant under the provisions of the RTI Act, 2005.
