- 5. The PIO is directed to supply remaining information to the appellant today, under intimation to the Commission. The Appellant is advised to send deficiencies, if any, in writing to the PIO after receiving the information. The PIO is also directed to remove the deficiencies, if any, received from the appellant and supply rectified information, under intimation to the Commission, before the next date of hearing.
