as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **18.4.2022** and Second Appeal was filed in the Commission on **30.5.2022** under Section 19 of the Right to Information Act, 2005. The case was last heard on **23.9.2022**.

2. The appellant is absent without intimation. The respondent PIO has submitted a comprehensive reply to the Show Cause Notice issued to him, along with copy of earlier reply sent to the appellant vide Letter No. 123 Dated 6.7.2022, along with partial information. As per the respondent PIO, the appellant refused to receive the said reply/information.

3. Subsequent to the Show Cause Notice issued to him, the respondent PIO has now submitted more comprehensive reply/information vide Letter No. 27 Dated 29.11.2022. The agreement
