ORDER:

1. This order may be read with reference to the previous order dated 05.04.2023 vide which it was observed that information is still pending. Respondent PIO was absent on the previous hearing even after issuing him show cause notice (vide order dated 03.01.2023). Accordingly, penalty amounting Rs.5,000/- was imposed on the concerned respondent PIO. Matter was adjourned to 30.5.2023.
2. In today's hearing, the appellant is present and states that information is still pending even after the directions of the Commission vide order dated 26.10.2022 for supplying the information within fifteen days.
3. Respondent PIO is absent third time without any intimation to the Commission. He was also absent on previous hearings held on 03.01.2023 and 05.04.2023.
4. On hearing held on 03.01.2023 show cause notice was issued to the respondent PIO and no reply is received till date.
5. On hearing held on 05.04.2023, penalty amounting Rs. 5,000/- was imposed on respondent PIO and compliance report is still not received by the Commission.
6. In wake of above, **Penalty amounting Rs. 5,000/- which was imposed on the concerned respondent PIO, O/o Secretary, Regional Transport Authority, Faridkot vide order dated 03.01.2023 passed by the undersigned Bench is enhanced to Rs. 10,000/-**
7. The Drawing and Disbursing Officer of the office of Secretary, Regional Transport Authority, Faridkot is directed to deduct the amount of penalty of Rs. 10,000/- from the salary of the concerned respondent PIO and be deposited in the State Treasury in the following Head of Account and to report its compliance to the Commission:-
