2. The commission is in receipt of email dated 10.10.2022 from O/o BDPO Nabha the relevant portion of which is reproduced below:

4. Respondent, Sh. Jatinder Singh stated that sought reply (as mentioned above) has been sent to the appellant dated 10.10.2022 through registered post.
5. Keeping in view the facts of the case and going through the RTI application the Commission observes that for the information already in public domain is no longer held by the public authority and the public authority is not obliged to provide the same to an applicant.

The Appeal stands **disposed** with the above direction.
