ORDER (THIRD HEARING):

1. This order may be read with reference to the order dated 05.04.2023 passed by this Bench on the previous hearing.
2. The Respondent states that available information has already been supplied to the appellant.
3. The Appellant states that incomplete information has been provided to him.
4. The perusal of the case reveals that the PIO has not provided complete information to the appellant after the lapse of the 11 months period. Therefore, **SHOW CAUSE NOTICE** under Section 20(1) of the RTI Act is issued to the Public Information Officer O/o Block Development & Panchayat Officer, Block-I, Ludhiana to explain as to why penalty should not be imposed upon him for willful delay/denial in supplying the information to the RTI applicant and why the compensation be not awarded to the appellant under the provisions of the RTI Act, 2005.
5. The PIO is further directed to file a reply to the Show Cause Notice and provide the remaining information to the appellant, before the next date of hearing, failing which **PENALTY** will be imposed upon him as per provisions of the RTI Act, 2005.
