Therefore, <u>SHOW CAUSE NOTICE</u> under Section 20(1) of the RTI Act is issued to the Public Information Officer O/o Block Development & Panchayat Officer, Block Gidderbaha, District Sri Muktsar Sahib to explain as to why penalty should not be imposed upon him for willful delay/denial in supplying the information to the RTI applicant and why the compensation be not awarded to the appellant under the provisions of the RTI Act, 2005.
- The PIO is further directed to file a reply to the Show Cause Notice and provide the remaining information to the appellant, before the next date of hearing, failing which <u>PENALTY</u> will be imposed upon him as per provisions of the RTI Act, 2005.
