## **Appeal Case No. 27 of 2022 (Video Conference Proceedings)**

ORDER:

*(To be read in continuity with earlier orders on **21.7.2022 and 29.9.2022**)*

1. The RTI application is dated **16.7.2021** vide which the appellant has sought information **regarding Letter No.153/ATP/A/D dated 14.7.2021**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **28.9.2021** and Second Appeal was filed in the Commission on **17.12.2021** under Section 19 of the Right to Information Act, 2005. The case was last heard on **29.9.2022**.
2. The appellant is present and states that no information has been provided to him by the PIO. On the last date of hearing on 29.9.2022, a show cause notice was issued to the PIO-cum-ATP, Zone A, MC, Ludhiana, as well as the PIO-cum-Superintendent, Headquarters, M.C. Ludhiana. While the PIO-cum-ATP, Zone A, MC, Ludhiana, has submitted a reply to the Show Cause Notice vide Letter No. 275 Dated 18.11.2022, the PIO-cum-Superintendent, Headquarters, M.C. Ludhiana has neither made any written submission nor is he available in person.
3. The Commission deems it fit to issue a **Bailable Warrant** against the PIO-cum-Superintendent, Head Quarter to ensure his presence on the next date of hearing.
4. At the last date of hearing on 29.9.2022 the PIO-cum- ATP, Zone A, MC, Ludhiana, was also directed to retrieve the information at point no. 1, 2, 3, 4, and 5 and supply attested copies of the same to the appellant within 20 days of receipt of the Order. The PIO-cum-ATP, Zone-A has failed to comply with the order. He is given one final opportunity to comply with para 6 of this Commission order Dated 29.9.2022. The PIO-cum-Superintendent, Head Quarters, M.C. Ludhiana, was similarly directed to retrieve the information pertaining to point no. 6, 7 and 8 of the RTI application from the office of MTP, MC,
