ORDER

- This order may be read with the reference to the order dated 14.11.2022 passed by this 1. Bench on the previous hearing.
- 2. The case has been heard today in the Commission's office at Chandigarh. The Appellant, Shri Mohit Kamboj comes present in person before the Bench and states that he has not been provided information by the PIO after removal of deficiencies pointed out by him.
- 3. Shri Abhinav Jain, Assistant Corporation Engineer/ PIO, Municipal Corporation, Abohar, comes present to attend the hearing in person before the Bench and states that information has been supplied to the appellant on 06.06.2022.
- The appellant confirms the receipt of letter dated 06.06.2022 and states that he had pointed out deficiencies to the PIO with a copy to the Hon'ble Commission on 10.08.2022 and no rectified information has been received after removal of deficiencies. He also hands over a copy of the deficiencies to the PIO in the court itself.
- The Bench points out to the PIO that the PIO of M.C. Abohar has absented himself for three consecutive hearing prior to today's hearing. On enquiring from him regarding the removal of deficiencies pointed out by the appellant, it transpires that he has come to attend the hearing not fully prepared with the facts of the case and has also not filed reply to the show cause notice.
- Post deliberations, the Bench directs the PIO to remove the deficiencies pointed out by the appellant and supply rectified information before the next hearing and also ensure to file reply to the show cause notice.
- With the aforesaid directions, the matter is adjourned. To come up for hearing on 6. 24.01.2023 at 11.30 AM before the Bench in Commission's office at Chandigarh. Copies of the order be sent to the concerned parties.
