#### **ORDER**

- 1. This order may be read with the reference to the order dated 19.12.2022 passed by this Bench on the previous hearing.
- 2. The case has been heard today in the Commission's office at Chandigarh. The Appellant, Shri Mohit Kamboj comes present in person before the Bench.
- 3. Shri Mangat Ram, Junior Assistant, Municipal Corporation, Abohar, comes present to attend the hearing in person before the Bench and states that information has been supplied to the appellant on 06.06.2022 and deficiencies were pointed out by appellant on 21.12.2022. Thereafter, rectified information has been supplied to the appellant vide letter dated 20.01.2023 which was acknowledged by him. He also produces before the Bench reply to the show cause notice dated 23.01.2023, which is taken on record..
- 4. The appellant confirms the receipt of letter dated 20.01.2023 and, however, states that there has been inordinate delay in supply of information and appropriate action regarding imposition of compensation/penalty etc. needs to be taken against the PIO.
- 5. On the filing of reply by the PIO to the show cause notice, the same is dropped. The Bench also considers the submission made by the appellant before the Bench, however, observes that the PIO has been replying to the appellant intermittently, the Bench does not accept the contention of the appellant and is not inclined to proceed further in the matter.
- 6. In view of the above, **the instant appeal case is disposed off and closed**. Copies of the order be sent to the concerned parties.
