ORDER

1. The RTI application dated 3.10.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 24.11.2022 and second appeal was filed in the Commission on 3.01.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. Notice of hearing was issued to the parties for hearing for 16.5.2023 at 11.00 a.m. through CISCO WEBEX application.
3. In today's hearing, both the parties are present.
4. Appellant, Ms. Deepti Saluja states that information is still pending.

7. Both the parties are advised to represent this case in person on the next date of hearing, failing to which, appropriate order in their absence shall be passed.
8. With the aforesaid directions, the matter is adjourned. Both the parties are directed to come up on **04.07.2023 at 11:00 A.M. through CISCO-Webex** (Video Conferencing application).
