Facts of the case:

- 1) In the above mentioned case, vide order dated 30.07.2019 penalty of Rs 25,000/- was imposed upon Sh. Charanjit Singh, Panchayat Secretary, by Ld. State Information Commissioner, Sh. Yashvir Mahajan.
- 2) The above said order dated 30.07.2019 was challenged by Sh. Charanjit Singh, Panchayat Secretary in Hon'ble Punjab and Haryana High Court and through CWP No. 28579 of 2019 the above said order (dated 30.07.2019) was stayed
- 3) Further, this case was heard by Ld. State Information Commissioner, Sh. Avtar Singh Kaler on 17.03.2020 and adjourned Sine-die as a CWP No. 28579 of 2019 was pending in the Hon'ble Punjab and Haryana High Court.
- 4) The Hon'ble Punjab and Haryana High Court vide order dated 25.04.2022 has decided the case as dismissed as withdrawn.
