**ORDER**

1. This order may be read with reference to the previous order dated **22.11.2022** vide which the respondent PIO was directed to supply an affidavit in original as per RTI application to the appellant with a copy to the Commission within seven days after receipt of that order.  
Ms. Pooja Maan was also advised to appear on the fixed date and time before the Commission for hearing, so that case could be concluded accordingly. The matter was adjourned to 17.01.2023.
2. In today's hearing, representative of the appellant, Sh. Bhrigu Sharma, Advocate states that status is same as it was on the previous hearing held on 22.11.2022.
3. The representative of the PIO states that Ms Pooja Maan has some work that is why she is unable to attend the hearing. He adds that reply to Show-cause was sent to the Commission, received vide diary no. 29104 dated 19.12.2022 and taken on record.

In view of the above, the court while taking suo moto cognizance of the situation, once again directs the respondent PIO for the compliance of previous order dated 22.11.2022 within 7 days from today, failing which penalty shall be imposed upon the concerned respondent PIO. A copy of this order be send to her by name for her ready reference.
5. Both the parties are advised to represent this case in person on the next date of hearing, failing to which, appropriate order in their absence shall be passed.
6. The matter is adjourned for further hearing on **07.02.2023 at 11:00 A.M. through CISCO WEBEX** application. Copy of the order be sent to the parties.
