as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **21.4.2022** and Second Appeal was filed in the Commission on **17.6.2022** under Section 19 of the Right to Information Act, 2005. The case was last heard on **17.11.2022**.

2. The appellant is absent for second successive hearing. The respondent PIO, represented by Sh. Vaneet Kumar, SDO, Zone-D, has submitted a copy of reply sent to the appellant vide Letter No. 533 Dated 19.1.2023, along with the requested information.

3. The Commission has examined the same and is of the view that this adequately addresses the RTI application. This Appeal is accordingly **Disposed of**.
