Appeal Case No. 2860 of 2022

2. The appellant is absent but has informed the Commission of his inability to attend this hearing. The information requested in this RTI application is identical to that sought in Appeal Case No. 2859/2022. The respondent PIO represented by Sh. Naresh Kumar, Clerk from Building Branch Zone D, states that a reply was first sent to the appellant vide Letter No. 04 Dated 11.4.2022, wherein he was informed that the area pertaining to which information has been sought is not within the building control of the Municipal Corporation. The appellant was duly informed that said area falls within the jurisdiction of Improvement Trust, Ludhiana. A second letter was sent to the appellant vide No. 259 Dated 9.11.2022, after he filed Second Appeal to the Commission.
