ORDER:

1. The RTI application is dated **11.3.2022** vide which the appellant has sought information:

Notice was issued to the parties for first hearing in the Commission on **24.11.2022**.

2. Both parties are present. The respondent PIO. represented by Gurpreet Singh, HDM from MTP's office, has submitted a copy of reply sent to the Appellant vide Letter No. 70 Dated 4.4.2022, whereby the requested information was denied citing the Hon'ble Supreme Court's Order in Civil Appeal Case No. 10044 of 2010 titled *Central Public Information Officer, Supreme Court of India V/s Subhash Chander Aggarwal* and Judgment of the Hon'ble High Court of Delhi in *LPA No. 190/212 Ashok Kumar Goyal V/s Public Information Officer, VAT Ward No. 64 and ANR*. The PIO's reply is hereby upheld.
