ORDER:

- 1. The RTI application is dated **24.3.2022** vide which the appellant has sought information **regarding Janak Roxy**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **27.4.2022** and Second Appeal was filed in the Commission on **20.6.2022** under Section 19 of the Right to Information Act, 2005. Notice was issued to the parties for first hearing in the Commission on **24.11.2022**.
- 2. Both parties are present. This RTI application was submitted on 24.3.2022 since when, the respondent PIO has not submitted any reply/information. The Commission takes a very serious view of the respondent PIO's conduct and deems it fit to issue him the Show Cause Notice. The Commission deems it fit to issue Show Cause Notice to the PIO-cum-ATP, Zone, B, Sh. Sunil Kumar.
- 3. The respondent <u>PIO-cum-ATP</u>, <u>Zone</u>, <u>B</u>, <u>Sh</u>. <u>Sunil Kumar</u>, is herewith ordered to <u>SHOW</u> <u>CAUSE</u> as to why a penalty should not be imposed upon him under Section 20 (1) of RTI Act, 2005, for causing willful delay/denial of the information requested by the appellant as far back as on **24.3.2022**.

"In addition to the written reply, the respondent PIO is also given an opportunity under Section 20 (1) provision there to, for a personal hearing before the imposition of such penalty on the next date of hearing. He may take note that in case he does not file his written reply and does not avail himself of the opportunity of personal hearing on the date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him *ex parte*." Copies of this order be sent to the parties through registered post.
