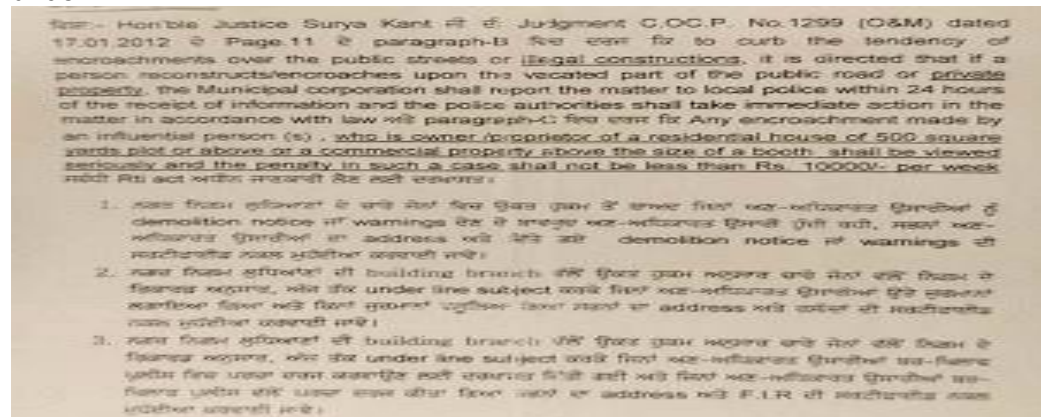

enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **3.11.2020** and Second Appeal was filed in the Commission on **31.12.2020** under Section 19 of the Right to Information Act, 2005. The case was last heard on **7.10.2022**.

2. Both parties are present. As directed by the Commission at the last Hearing on 7.10.2022, the PIOs Building Branch for Zone A, B, and C, have supplied the requested information to the appellant. The appellant states that he is satisfied, although he has pointed out minor deficiency in the information provided by Zone C. These were listed to the APIO-cum-Building Inspector Zone C, Ms. Kashish Garg, who has agreed to search the record for any pending information.

3. This Appeal Case is accordingly **Disposed of**.
