- 2. The Appellant states that information sought has not been provided to him.
- 3. The PIO is again absent for today's hearing and he was also absent on the last hearing dated 14.12.2022, inspite of the Notice/Orders of the Commission. This shows his disregard to the Commission. The absence of the PIO is viewed seriously and it has also affected hearing and disposal of the case.
- 4. The perusal of the case reveals that the PIO has neither provided the requisite information to the appellant nor pursue this case personally or through his representative, even after the lapse of the 12 months period.
- 5. In view of the above, a <u>SHOW CAUSE NOTICE</u> under Section 20(1) of the RTI Act is issued to the Public Information Officer O/o B.D.P.O., Block Nabha, District Patiala to explain as to why penalty should not be imposed upon him for wilful delay/denial in supplying the information to the RTI applicant and why the compensation be not awarded to the appellant under the provisions of the RTI Act, 2005.
