ORDER:

1. This order may be read with reference to the order passed by this Bench on the previous hearing.
2. The case has been heard today. Shri Kawaljeet Singh, appellant has not come present to attend the hearing in person before the Bench or through cisco webex.
3. Shri Subeg Singh, Junior Engineer, Civil Division, Municipal Corporation, Amritsar, comes present to attend the hearing on behalf of PIO/ Respondent through cisco webex. Shri Subeg Singh states that information has been sent to the appellant vide letter dated 30.08.2022 sent by registered post on 31.08.2022. The letter is also supported by photographs taken on the spot by the officials who had visited the site.
4. The appellant Shri Kawaljeet Singh is contacted on mobile phone. On the asking of the Bench, he is not able to apprise the Bench of the factual position regarding receipt of information and seems to be not fully conversant with the complete facts of the case. The Bench observes that the appellant has absented himself for both the hearings without any intimation to the Bench and when
