**ORDER**

1. This order may be read with reference to the order dated 08.12.2022 passed by this Bench on the previous hearing.
2. The case has been heard today in the Commission's office at Chandigarh. Shri Rohit Sabharwal, appellant has not come present in person before the Bench or through cisco webex. However, an e.mail dated 04.01.2023 has been received from Mrs. Sukhjinder Kaur, representative of the appellant stating that the appellant has not been supplied information so far and that she may be exempted from personal appearance for the hearing.
3. Shri Sanjeev Uppal, Superintendent, Tehbazari Branch, Zone-C, M.C. Ludhiana comes present to attend the hearing in person before the Bench. 4. The representative of appellant Mrs. Sukhjinder Kaur is contacted on her mobile phone and is made to talk to the PIO, who explains to her the details of information supplied point wise. She denies receipt of information. Then, on the asking of the Bench, the PIO sends information to the representative of appellant on her WhatsApp number.

5. Post deliberations, the representative of appellant requests for short adjournment to go through the information supplied and then to apprise the Bench of her observations. The request of the appellant is acceded to.
