**ORDER:**

1. This case may be read with the reference of the previous order dated 05.01.2023, in which it was mentioned that the penalty amount of Rs. 15,000/- has been deposited in the Government Treasury and that the information was sent to Ms. Sukhjinder Kaur, representative of the appellant on her mobile on 05.01.2023 and an adjournment was given to the parties, as representative of the appellant wanted to go through the supplied information and point out the deficiencies, if any.
