### BACKGROUND:

I have applied for the certified copy of the police complaint lodged against me at Anaj Mandi Police Station Patiala in April 2021 through RTI as well as Request Letter. When I didn't receive any Information in stipulated time I decided to complaint against the investigating official Mr. Pargat Singh to Vigilance Bureau Punjab.

After reaching complaint to Vigilance Bureau, I received a call from Mr. Pargat Singh on 12/03/2022 that neither he nor any other at their office haven't received any letter of request. He also denied to provide the said information citing the reasons that there is no provisioning to provide information through Request Letter.

## Appeal Case No. 2922 of 2022 (Video Conference Proceedings)

In the light of the above mentioned background, please provide the following information under section 2(f) and 2(j) of the RTI act:

- 1) A certified copy of the said complaint filed against Pradeep Kumar at Anaj Mandi Police Station Patiala in April 2021. The Complaint number is 2843/peshi dated 21.04.2021
  - 2) A certified copy of the rules, under which the said official has denied to provide information through Request Letter.
  - 3) The details of the Dak Receiving and Disposal Official of Anaj Mandi Police Station Patiala.
  - 4) A certified copy of the investigation report made by Mr. Pargat Singh of the complaint filed against Pradeep Kumar at Anaj Mandi Police Station Patiala in April 2021.
  - 5) If no investigation is done then provide the reason for the same.
- (iv). Whether information is required by post or in person : By Post
- (v). In case by post (ordinary, Registered or Speed post): Registered

as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **4.5.2022** and Second Appeal was filed in the Commission on **21.6.2022** under Section 19 of the Right to Information Act, 2005. The case was last heard on **3.11.2022**.

2. The appellant is absent. The respondent PIO, represented by Sh. Amandeep Singh, Senior Assistant from the office of SSP, Patiala and Head Constable Deepak Kumar from the PS Women Cell, Patiala, have submitted a reply vide Letter No. 1546 Dated 12.12.2022, along with certified copy of complaint no. 2843/peshi as cited in the RTI application.
