ORDER

1. This order may be read with reference to the previous order dated 22.09.2022 vide which respondent, Sh. Gurmeet Singh stated that the information has already been sent to the appellant but through ordinary post, but appellant denies receipt of the same. Accordingly respondent PIO was directed send the information to the appellant again through registered post immediately. The appellant was also advised to point out deficiencies, if any, within 7 days from its receipt, failing which the case shall be decided on merits. Matter was adjourned for further hearing on 29.11.2022 i.e. today.
2. In today's hearing, appellant states that nothing is supplied to him even after the directions of the Commission vide order dated 22.09.2022.
3. Respondent PIO is absent in spite of registered post order issued to him, indeed a serious matter, as it also affects the disposal of the case.
4. In view of the foregoing, **respondent PIO, O/o Secretary, RTA, Ferozepur is directed to show cause** in writing or through affidavit under Section 20(1) of the RTI Act, as to why penalty be not imposed upon him for willful delay/ denial of the information to the RTI applicant and why the compensation be not awarded to the complainant under Section 19 (8)(b) of the Act for detriment suffered.

In addition to his submission, the PIO is also hereby given an opportunity under Section 20(1) proviso, thereto, for a personal hearing before the imposition of such penalty on the next date of hearing. He may note that in case he does not file his submission and does not avail himself of the opportunity of personal hearing on the next date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex-parte.

5. Respondent PIO is directed to supply the demanded information to the appellant within ten days after receipt of this order under intimation to the Commission.
6. Appellant is advised to point out deficiencies, if any, within 7 days from its receipt as per RTI application, failing which the case shall be decided on merits.
