**ORDER**

1. The RTI application is dated 16.03.2022 vide which the Complainant has sought information as enumerated in her RTI application. Complaint was filed in the Commission on 20.05.2022 under Section 18 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The aforesaid Complaint Case was remanded back to the First Appellate Authority O/o Municipal Corporation, Amritsar vide order dated 09.08.2022 with the direction to hear the complainant within 10 days and to decide the case. The complainant vide letter 28.12.2022 (wrongly mentioned as 28.02.2022) has informed that the First Appellate Authority though has assured to redress her grievance but has not got her information as per RTI application. Thus, the above said complaint case has been converted into Appeal Case and the notice of hearing was issued to the parties for 06.02.2023.
2. The case has been heard today. Shri Ashwani, comes present to attend the hearing in person before the Bench on behalf of Ms. Rani, appellant.
3. Shri Ramesh Kumar, Junior Assistant PIO O/o Commissioner, Municipal Corporation, Amritsar comes present to attend the hearing in person before the Bench and states that the grievance of Smt. Rani as raised in her RTI application has been redressed and inputs provided to her vide letter dated 03.02.2022, with a copy by e.mail to Hon'ble Commission.
4. Shri Ashwani, the representative of Smt. Rani, appellant confirms that the grievance of the appellant has been redressed by the PIO to the satisfaction of the appellant.
5. In view of the above, no further cause of action is left in the matter. **As such, the case is disposed off and closed.** Copy of the order be sent to the parties.
