ORDER

1. The RTI application is dated 04.04.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 04.05.2022 and the second appeal was filed in the Commission on 22.06.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). The above mentioned case i.e. AC: 2940 /2022 was fixed for 06.09.2022 but it was postponed and is fixed for today's hearing.

2. In today's hearing, the Appellant, Shri Madan Lal states that he has received incomplete information. He further hands over letter of deficiencies dated 01.10.2022 to Shri Manjeet Singh, ASI as well as a copy of same the bench of undersigned during the hearing, which is taken on record.

3. On the asking of the Bench, Shri Manjeet Singh, ASI assures that the deficiencies as mentioned by the Appellant will be removed by the next hearing. He also mentions that a copy of information has also been sent to the bench of undersigned vide letter dated 27.09.2022, which is taken on record.

4. The Bench directs the PIO to supply the point wise requisite information (after removing the deficiencies as per RTI) to the Appellant, Shri Madan Lal by the next hearing through registered post.

5. The PIO concerned is directed to appear in person along with information supplied and related documents, on the next date of hearing at the Commission.

6. With the aforesaid directions, the matter is adjourned. **Both the concerned parties are directed to come up for hearing on 02.11.2022 at 11.30 AM before the Bench in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.
