ORDER:

1. The RTI application is dated 22.03.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 11.05.2022 and the second appeal was filed in the Commission on 22.06.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). The above mentioned case i.e. AC: 2968 /2022 was fixed for 06.09.2022 but it was postponed and is fixed for today's hearing.
2. The case has been heard today in the Commission's office at Chandigarh. The Appellant, Shri Mahinder Singh is absent.
3. Shri Deepak Chugh states that the information has been sent to the Appellant, Shri Mahinder Singh's address twice through speed post vide letter dated 31.08.2022 and 30.09.2022, but he refused to accept it and the same has been received back by their office.
4. Post deliberation, the Bench directs the PIO to supply the point wise requisite information (again through registered post) to the Appellant, Shri Mahinder Singh by the next hearing and submit the proof to the bench of undersigned of sending the information to the Appellant.
5. A copy of information along with letter number 31.08.2022 and 30.09.2022 be sent to the Appellant, Shri Mahinder Singh along with this order through registered post.
6. Both the parties are directed to appear before the undersigned bench along with all the requisite record for clarifying the facts of this case on the next hearing.
7. With the aforesaid directions, the matter is adjourned. **Both the concerned parties are directed to come up for hearing on 07.11.2022 at 11.30 AM before the Bench in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.
