ORDER

1. The RTI application is dated 09.08.2021 vide which the appellant has sought information as enumerated in her RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 06.10.2022 and the second appeal was filed in the Commission on 23.06.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). The above mentioned case i.e. AC: 2983 /2022 was fixed for 06.09.2022 but it was postponed and is fixed for today's hearing.
2. The case has been heard today in the Commission's office at Chandigarh. Shri Sardool Singh, ASI hands over a copy of information vide letter dated 18.08.2022 to the Appellant, Ms. Rajni during the hearing and a copy of the same has also been submitted to the bench of undersigned, which is taken on record.
3. After going through the letter dated 18.08.2022, the Appellant, Ms. Rajni shows her dissatisfaction and further requests for information to her RTI application.
4. Post deliberation, the Bench directs the Appellant, Ms. Rajni to point out deficiencies to the PIO concerned through registered post and submit a copy of the same to the bench of undersigned through email within seven days from today.
5. The Bench directs the PIO to supply the point wise requisite information (after removing the deficiencies as per RTI) to the Appellant, Ms. Rajni by the next hearing through registered post.
6. The PIO concerned is directed to appear in person along with information supplied and related documents, on the next date of hearing at the Commission.
7. With the aforesaid directions, the matter is adjourned. **Both the concerned parties are directed to come up for hearing on 07.11.2022 at 11.30 AM before the Bench in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.
