**ORDER**

1. This order may be read with reference to the order dated 07.11.2022 passed by the Bench during the previous hearing.

It be further stated that nothing has been concealed therein and the statement made is true and correct. Original affidavit be brought along and produced before the Bench on the next hearing. The appellant is also directed to come present in person before the Bench on the next hearing.
6. With the aforesaid directions, the matter is adjourned. **To come up for hearing on 31.01.2023 at 11.30 AM before the Bench in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.
