**Present:** (i) The Appellant, Shri Gagan Bali is present through Cisco Webex.

**ORDER**

1. The RTI application is dated 17.11.2021 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 08.02.2022 and the second appeal was filed in the Commission on 24.06.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). The above mentioned case i.e. AC: 2989 /2022 was fixed for 06.09.2022 but it was postponed and is fixed for today's hearing.

2. The case has been heard today in the Commission's office at Chandigarh. The Appellant, Shri Gagan Bali states that incomplete information has been supplied to him.

3. Neither the PIO has come present to attend the hearing in person before the Bench nor through cisco webex nor he has deputed any of his representatives to attend the hearing on behalf of the PIO. A letter dated 24.03.2022 and 05.09.2022 has been received to the bench of undersigned from the office of MC, Amritsar which is taken on record.

4. Post deliberation, the Bench directs the Appellant, Shri Gagan Bali to point out deficiencies to the PIO concerned through registered post and submit a copy of the same to the bench of undersigned through email within seven days from today.

5. The Bench directs the PIO to supply the point wise requisite information (after removing the deficiencies as per RTI ) to the Appellant, Shri Gagan Bali by the next hearing through registered post.

6. The PIO concerned is directed to appear in person along with information supplied and related documents, on the next date of hearing at the Commission.

7. With the aforesaid directions, the matter is adjourned. **Both the concerned parties are directed to come up for hearing on 07.11.2022 at 11.30 AM before the Bench in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.
