The Appellant, Shri Gagan Bali is present through Cisco Webex. None is present from the department.

Versus

1. The RTI application is dated 17.11.2021 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 08.02.2022 and the second appeal was filed in the Commission on 24.06.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). The above mentioned case i.e. AC: 2989 /2022 was fixed for 06.09.2022 but it was postponed and is fixed for today's hearing.
