**ORDER:**

1. This order may be read with reference to the order dated 28.09.2022 passed by this Bench on the previous hearing.
2. The case has been heard today. Shri Baljit Singh, appellant comes present to attend the hearing in person before the Bench.
3. Smt. Yamini, SDO, and Smt. Anita Rani, Superintendent, Sub Division, PSPCL, Fazilka, come present to attend the hearing in person before the Bench on behalf of PIO/Respondent. Smt. Yamini states that the information as sought by the appellant has been supplied vide letter dated 27.10.2022.
4. On the asking of the Bench, the appellant states that information on point No.3 has not been supplied. Smt.Yamini, SDO states that the said document has not been found diarised in the office and thus, could not be supplied.

Post deliberations, the Bench directs the PIO to file an affidavit on e-Stamp paper, within 21 (twenty one) days, duly signed by the PIO and attested by the Notary Public to the effect that the information has been supplied to the appellant as available in official records in AC No.3728/2022, except information on point No.3 as the said document has not been found diarised in their office. It be further stated that nothing has been concealed therein and the statement made is true and correct. Original affidavit be sent to the appellant and copy of the same be sent to the Commission for record.

6. With the aforesaid directions, the **instant appeal case is disposed off and closed.**
