ORDER:

1. The RTI application is dated 09.05.2022 vide which the Appellant has sought information as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (hereinafter FAA) on 20.06.2022 and Second Appeal was filed in the Commission on 31.10.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act) and Notice of hearing was issued to the parties for 29.05.2023.
2. The Appellant states that information sought has not been provided to him.
3. The PIO is absent for today's hearing, in spite of the Notice/Orders of the Commission. This shows his disregard to the Commission. The absence of the PIO is viewed seriously as it has affected the hearing and disposal of the case.
4. The PIO is directed to provide the requisite information/reply to the appellant, before the next date of hearing and should appear personally through Cisco Webex, on the next date of hearing, failing which strict action will be initiated against the PIO as per provisions of the RTI Act, 2005.
