ORDER

This case may be read with the reference of the previous order dated 21.09.2022 vide which
respondent PIO was directed to go through the RTI application and supply the information to the
appellant within ten days after receipt of this order, failing which stern action will be initiated against
the concerned respondent PIO.

It was also observed that appellant earlier demanded information relates with DMLT course in another appeal case no. 3643 of 2020, which was disposed of & closed by the undersigned Bench vide order dated 31.03.2021.

Appellant was also advised to represent this case on the next date of hearing to clear the facts, failing which case will be decided on merit basis. Matter was adjourned for further hearing on 13.12.2022.

- In today's hearing the appellant states that no information has been supplied to him. He further
 mentions about his email dated 11.10.2022 is sent to the undersigned Bench, which is seen and
 taken on record.
- 3. None is present from the department in spite of registered post order issued to him by the Commission.
- 4. Commission takes a serious view of the casual approach of the Respondent / PIO. In view of the foregoing, <u>respondent PIO O/o Department of Technical Education, Punjab, Chandigarh is directed to Show Cause</u> in writing or through affidavit under Section 20(1) of the RTI Act, as to why penalty be not imposed upon him for willful delay/ denial of the information to the RTI applicant and why the compensation be not awarded to the complainant under Section 19 (8)(b) of the Act for detriment suffered.

In addition to his submission, the PIO is also hereby given an opportunity under Section 20(1) proviso, thereto, for a personal hearing before the imposition of such penalty on the next date of hearing. He may note that in case he does not file his submission and does not avail himself of the opportunity of personal hearing on the next date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex-parte.

5. A copy of this order be also sent to the First Appellate Authority i.e. The Director, Department of Technical Education, Punjab, Chandigarh for the compliance of this order and to look into the matter as RTI Act, 2005 came into existence to promote transparency and accountability in the working of every public authority, not for the harassment of the public.
