- 5) PLS ALSO PROVIDE ME WITH INFORMATION AS OF DATE THE COLLECTION OFDOOR TO DOOR GARBAGE WASTE OF AREAS FALLING WITH MC LIMITS, PATIALA IS BEING DONE BY STAFF OF MUNICIPAL CORPORATION PATIALA OR ANY OTHER AGENCY (NAME IF ANY OTHER AGENCY FOR COLLECTION).

as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **11.5.2022** and Second Appeal was filed in the Commission on **27.6.2022** under Section 19 of the Right to Information Act, 2005. The case was last heard on **18.11.2022**.

- 2. Both parties are present. The PIO-cum-Medical Officer, Health Branch, who was issued a Show Cause Notice on 18.11.2022, is present and has submitted a copy of the reply sent to the appellant signed by Chief Sanitary Inspector vide Letter No. 92 Dated 27.1.2023. The reply pertains to point no. 1 and 2 of the RTI application.
- 3. The PIO-cum-Medical Officer, Health Branch is hereby directed to submit aforesaid reply by way of a duly notarized affidavit. If needed, she can seek report from concerned officer in writing before submitting said affidavit within 10 days of receipt of this Order.
- 4. This Appeal Case is accordingly **Disposed of**.
