**ORDER**

1. The RTI application is dated 22.12.2021 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 31.01.2022 and the second appeal was filed in the Commission on 27.06.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). The above mentioned case i.e. AC: 3038 /2022 was fixed for 06.09.2022 but it was postponed and is fixed for today's hearing.

2. The case has been heard today in the Commission's office at Chandigarh. Shri Narinder Singh, Clerk states that information has been supplied to the Appellant, Shri Tejinder Singh vide letter 04.10.2022. He further mentions about a letter dated 04.10.2022 which has been sent to the bench of undersigned.

3. On the asking of this bench, the Appellant, Shri Tejinder Singh states that he has received incomplete information and further mentions that he will point out the deficiencies to the PIO concerned.

4. Post deliberation, the Bench directs the Appellant, Shri Tejinder Singh to point out deficiencies to the PIO concerned through registered post and submit a copy of the same to the bench of undersigned through email within seven days from today.

5. The Bench directs the PIO to supply the point wise requisite information (after removing the deficiencies as per RTI ) to the Appellant, Shri Tejinder Singh by the next hearing through registered post.

6. The PIO concerned is directed to appear in person along with information supplied and related documents, on the next date of hearing at the Commission.

7. With the aforesaid directions, the matter is adjourned. **Both the concerned parties are directed to come up for hearing on 07.11.2022 at 11.30 AM before the Bench in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.
