ORDER:

1. The RTI application is dated 22.03.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 19.04.2022 and the second appeal was filed in the Commission on 27.06.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). The above mentioned case i.e. AC: 3040 /2022 was fixed for 06.09.2022 but it was postponed and is fixed for today's hearing.

2. The case has been heard today in the Commission's office at Chandigarh. The Appellant, Shri Manohar Lal states that partial information has been received by him. He further states that he wants to know about CSR rules under which the cut in pension has been made from the date of retirement whereas it should have been imposed from the date the PPO was allotted.

3. On the asking of the Bench, Shri Ishar Chand, AAO states that CSR is silent in such cases and gives no clarification.

4. The Bench directs the PIO O/o Deputy Chief Accounts to file an affidavit on e-stamp paper, within 21 (Twenty one) days, duly signed by the PIO and attested by the Notary Public to the effect that the information asked for by the appellant in his Appeal Case No.3040 / 2022 as available in official records has been supplied. Regarding, the contention of appellant for imposing cut on pension from the date of PPO, the CSR rules are silent and no information is available related to the issue raised. It be further stated that nothing has been concealed therein and the statement made is true and correct. Original affidavit be sent to the appellant and copy of the same be sent to the Commission for record.

5. With the aforesaid directions, **the instant appeal case is disposed off and closed.** Copies of the order be sent to the concerned parties.
