**ORDER**

1. The RTI application is dated 11.11.2021 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 23.12.2021 and the second appeal was filed in the Commission on 27.06.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). The above mentioned case i.e. AC: 3047 /2022 was fixed for 06.09.2022 but it was postponed and is fixed for today's hearing.
2. The case has been heard today in the Commission's office at Chandigarh. The Appellant, Shri Rattan Singh states that no information has been supplied to him till date.
3. Neither the PIO has come present to attend the hearing in person before the Bench nor through cisco webex nor he has deputed any of his representatives to attend the hearing on behalf of the PIO.
