ORDER

- 1. This order may be read with reference to the previous order dated 08.12.2022.
- 2. In today's hearing, the representative of the appellant, Shri Gurpreet Singh states that he did not receive reply in relation to the point number 7 of the RTI application as per the directions of the Commission on previous hearings held on 13.10.2022, 10.11.2022 and 08.12.2022. He adds that affidavit in connection with point no. 2 and 8 is received.
- 3. On the other hand, Shri Navtej Singh, Superintendent states that an affidavit dated 08.12.2022 and 10.01.2023 had already been supplied to the appellant and submits copies of both affidavits (dated 08.12.2022 and 10.01.2023), which are seen and taken on record.
- 4. After going through the case file and documents placed on record, I am of the considered view that sufficient information had already been supplied time and again. Respondent PIO complied with the previous orders of the Commission for supplying the affidavits as he was directed. It is also observed that reply in connection with point no. 7 is also satisfactory in the supplied affidavit dated 08.12.2022. Apart from this respondent PIO is directed to supply an affidavit in original in connection with point no. 7 to the appellant with a copy to the Commission within a weeks' time.
- 5. Accordingly, on the verbal statements made by the PIO, Shri Paramveer Singh, GM, the show cause notice which was issued to the PIO concerned vide order dated 08.12.2022 is **dropped**.
- 6. In wake of above, no further cause of action is required. Therefore, this case is <u>disposed off and</u> closed. Copy of the order be sent to the parties.
