ORDER:

1. This order may be read with reference to the previous order dated 28.09.2022 vide which both the parties were absent and the matter was adjourned for 22.12.2022, was postponed and fixed for today.
2. In today's hearing, respondent, Ms. Malkiat Kaur is present from the department states that RTI application does not relates with the respondent's office. She adds that reply had already been supplied to the appellant in this regard.
3. Appellant is not present and it is also observed that following notices and orders of the Commission which were sent to the appellant returned to the Commission with the following remarks:
 - Notice of hearing for 28.09.2022 returned to the Commission with remarks 'insufficient address' (vide diary no. 16380 dated 25.07.2022)
 - Copy of order passed in the instant appeal case on hearing held on 28.09.2022 returned to the Commission with remarks 'no such person in the address' (vide diary no. 23510 dated 14.10.2022)
 - Notice of postponement of hearing (from 22.12.2022 to 13.04.2023) returned to the Commission with remarks 'returned to the sender unclaimed'.

It is observed that address as per the case file is correct, as received from the Registry Branch of the Commission.

4. After hearing the respondent and examining the case file, it is observed that no communication is received from the appellant after issuing notice of hearing for 28.09.2022. A final opportunity is awarded to him to represent this case on the next date of hearing positively to clear the facts of this case, failing which case will be decided on merit basis.
5. Matter is adjourned for further hearing on **06.06.2023 at 11:00 A.M. through CISCO WEBEX.** Copy of the order be sent to the parties.
