ORDER:

1. This case may be read to the reference of the previous order dated 19.01.2023.
2. In today's hearing, the appellant, Sh. Manjinder Singh states that incomplete information has been supplied to him and inspection could not take place.
3. On the other hand, the Senior Assistant, Sh. Arvinder Singh verbally explains the facts about this case and the show cause notice which was issued to the PIO concerned is dropped. During the hearing, he further submits the letter number 454 dated 20.03.2032 and letter dated 05.01.2023, which are taken on record.
4. After going through case file and discussing with both the parties, I am of the view that the Appellant, Shri Manjinder Singh is directed to visit the concerned office on **10.04.2023 (MONDAY) at 11.00 a.m.** and meet the concerned PIO / officials for collection of record after inspecting the same as per his RTI.
5. If the Appellant, Shri Manjinder Singh will not visit for inspection on the said date and time then it would be presumed that he does not requires the information anymore and the case would be decided on merits.
6. The concerned PIO or other concerned officials are directed to be there at the time of inspection on the said date and time on the Appellant's visit so that he case could be concluded on the next date of hearing. The PIO is also directed to supply the information to the Appellant by hand or send the specific identified record to the Appellant within seven days from the date of inspection.
7. Matter is adjourned for further hearing on **10.05.2023 at 11:00 A.M. through CISCO WEBEX.** Copy of the order be sent to the parties.
