The concerned PIO or other concerned officials are directed to be there at the time of inspection on the said date and time on the Appellant's visit so that he case could be concluded on the next date of hearing. The PIO is also directed to supply the information to the Appellant by hand or send the specific identified record to the Appellant within seven days from the date of inspection.
- 7. Matter is adjourned for further hearing on 10.05.2023 at 11:00 A.M. through CISCO WEBEX. Copy of the order be sent to the parties.
