ORDER (Third Hearing):

1. This order may be read with the reference of previous order of the Commission dated 16.11.2022. (Due to some reason all the cases of hearing date 13.03.2023 were adjourned to 15.03.2023.)
2. **Written submission from respondent SHO Police station Shimlapuri:** An email dated 13.03.2023 is received by the undersigned bench the relevant portion of which is reproduced below:

3. After going through the submissions the respondent PIO, the Commission finds that the RTI application has been **suitably replied**. Moreover, **the factual position has been brought to the notice of the appellant by the respondent for further query, if any.**

Therefore, no cause of action is required in this case. Hence, the instant appeal case is **disposed & closed**.
