**ORDER:**

1. This order may be read with reference to the order dated 16.11.2022 passed by this Bench on the previous hearing.
2. The case has been heard today. Shri Jiwan Garg, appellant comes present to attend the hearing through cisco webex. He refers to his e.mail dated 02.12.2022 stating therein that he has pointed out deficiencies in the information supplied.
4. Shri Kuldeep Singh, RTI Assistant O/o SSP Sangrur attends the hearing in person before the Bench and states that the information sought by the appellant relates to different Police Stations in District Sangrur. He also produces before the Bench letter dated 10.12.2022 stating that information comprising 75 pages has been supplied to the appellant on 05.02.2021 and response to the observations raised by the appellant has also been given.
5. On the asking of the Bench, the appellant denies receipt of rectified information after removing the deficiencies pointed out by him and that copy of the Rules and Regulations sought by him vide his RTI application have also not been provided to him.

6. Post deliberations, the Bench directs the PIO O/o SSP Sangrur to again send copy of the letter dated 10.12.2022 to the appellant by registered post as also by e.mail. He is also directed to call the appellant to his office and allow him access to the relevant official records. The information as is identified by the appellant be provided to him before the next hearing and the appellant be also apprised of necessary Link to access the information relating to various points of his RTI application which are available on the website of the Department.

7. The appellant and the PIO O/o SSP Sangrur are directed to come present in person before the Bench on the next date of hearing.

8. With the aforesaid directions, the matter is adjourned. **To come up for hearing on 11.01.2023 at 11.30 AM in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.
