#### ORDER:

- 1. The RTI application is dated **4.4.2022** vide which the appellant has sought information regarding his application (Diary No. 2185/PS/R Dated **4.9.2020** and **2485/PS/R Dated 13.10.2020**) and the action thereon till date, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **9.5.2022** and Second Appeal was filed in the Commission on **4.7.2022** under Section 19 of the Right to Information Act, 2005. Notice was issued to the parties for first hearing in the Commission on **10.11.2022**.
- 2. Both parties are present. The respondent PIO has submitted a copy of detailed reply sent to the appellant vide Letter No. 794 Dated 3.11.2022, along with a pointwise reply sent earlier vide Letter No. 786 Dated 2.8.2022. After deliberations at this hearing, the PIO-cum-Superintendent, House Tax Branch, Zone B, Sh. Rajeev Bhardwaj, is directed to submit a notarized affidavit with respect to point no. 1 and 2 of this RTI application, clearly stating that all the information as available in his record, has been supplied to the appellant and there is no other information available in the record.
- 3. The PIO-cum-Superintendent, House Tax Branch, Zone B, is also directed to transfer point no. 3 and 4 of this RTI application to the PIO-cum-Superintendent, Establishment Branch, who is thereafter to submit a detailed pointwise reply to point no. 3 and 4 of the RTI application by way of a duly notarized affidavit along with the information as available in his record.
