## **Appeal Case No. 3130 of 2022 (Video Conference Proceedings)**

ORDER:

*(To be read in continuity with earlier orders on 10.11.2022)*

1. The RTI application is dated **4.4.2022** vide which the appellant has sought information **regarding his application (Diary No. 2185/PS/R Dated 4.9.2020 and 2485/PS/R Dated 13.10.2020) and the action thereon till date**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **9.5.2022** and Second Appeal was filed in the Commission on **4.7.2022** under Section 19 of the Right to Information Act, 2005. The case was last heard on **10.11.2022**.

2. Both parties are present. The respondent PIO-cum-Superintendent House Tax Branch Zone B, has submitted an affidavit, as directed by the Commission at para 2 of its Order of 10.11.2022. He had also transferred point no. 3 and 4 of the RTI application under Section 6(3) of the RTI Act, 2005, to the PIO-cum-Superintendent Establishment (*Amla*) Branch, whereupon the PIO-cum-Superintendent Establishment, has submitted a reply vide Letter No. 316 Dated 25.11.2022 with a reply to point no. 3 and 4 of the RTI application and the information pertaining to point no. 3. The appellant Sh. Kuldeep Singh, however, insists that the information provided is not what he has sought. He states that instead of providing copies of the orders upon which *Amla* Clerk Sh. Diya Ram, made a report regarding the writ petition cited in the RTI application, the PIO-cum-Superintendent Establishment Branch has only provided a copy of *Amla* Clerk's report and the application submitted by the petitioner, as cited in this RTI application.
