4. ਇਸ ਦੇ ਪੰਜਾਬ ਪੁਲੀਸ ਨੰਬਰ ਦੀ ਜਾਣਕਾਰੀ ਦਿੱਤੀ ਜਾਵੇ।
5. ਮੇਰੇ ਵਲੋਂ ਭੇਜੀ ਗਈ ਇਸ ਆਰ.ਟੀ.ਆਈ ਦੀ ਦਰਖਾਸਤ ਨੂੰ ਆਪ ਜੀ ਦੇ ਦਫਤਰ ਨੇ ਕੀ ਫਾਈਰੀ ਨੰਬਰ ਲਗਾਇਆ ਹੈ ਇਸਦੀ ਵੀ ਤਸਦੀਕ ਸੁਦਾ ਕਾਪੀ ਦਿੱਤੀ ਜਾਵੇ।

as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **20.4.2022** and Second Appeal was filed in the Commission on **4.7.2022** under Section 19 of the Right to Information Act, 2005. The case was last heard on **9.11.2022**.

2. Both parties are present. The appellant is present via Video Conference from Mohali. The respondent PIO, represented by Sh.
