1. The RTI application is dated **19.12.2020** vide which the appellant has sought **information regarding Gulmohar Valley-1, Village Kaulimajra, Tehsil Dera Bassi**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **1.2.2021**, and Second Appeal was filed in the Commission on **9.7.2021** under Section 19 of the Right to Information Act, 2005. The case was last heard on **19.10.2022**.

2. The respondent PIO-cum-Superintendent, Bohar Singh, was directed to submit a duly notarized affidavit pertaining to point no. 6 of the RTI application. Contrary to this Commission's direction, the PIO has brought a common affidavit in Appeal Case No. 3155/2021 and 3156/2021 that too does not clearly spell out the position with respect to the noting, correspondence etc. pertaining to point no. 6 of Appeal Case No. 3155/2021 and 3156/2021.

3. The respondent PIO is hereby directed to submit an appropriate affidavit as directed by the Commission in person on 1.11.2022.
