

ORDER (Third Hearing):

1. This order may be read with the reference of previous order of the Commission dated 19.10.2022 vide which respondent, ASI Sukhdev Singh submitted the copies of complete information pertaining to the RTI application comprising 66 pages in the court and a copy of the same was provided to the appellant. He further stated that no any other information pertaining to this RTI application is pending in the official record.

In view of this above, the Commission directed the PIO to furnish an undertaking providing therein the factual situation (as discussed above) and affirming the position that the information sought by the appellant has been supplied to best extent and what has been provided is true/correct.

- 2. Both the parties are present for hearing. Appellant Lt. Col. Ramandeep Singh stated that he is not satisfied with the information so supplied by the respondent authority in this case. Respondent PIO represented by ASI Jaswant Singh appeared clueless in respect of the nuances of the RTI Act and appeared without proper awareness about the facts of the case.
- 3. Written Submission/undertaking from Deputy Commissioner Police Jalandhar cum PIO: A correspondence dated 09.01.2023 vide letter reference no. 18 A-1 is received by the undersigned bench vide it mentioned that the sought information has already been provide to the appellant and no any other information is pending in the official record.

This correspondence is taken on record with all supporting enclosures.

A copy of this correspondence has been sent to the appellant by the respondent PIO.

4. Keeping in view the facts of the case and written submission made by the respondent PIO the commission finds that RTI application in this instance had been adequately addressed and the information has been supplied to the **best extent**. There is no further cause for action and this appeal case is herewith CLOSED.
