ORDER:

1. The RTI application is dated 07.06.2022 vide which the Appellant has sought information as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (hereinafter FAA) on 11.10.2022 and Second Appeal was filed in the Commission on 17.11.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act) and Notice of hearing was issued to the parties for 31.05.2023.
2. The aforesaid complaint case was remanded back by this Bench to First Appellate Authority i.e. Commissioner of Police, Ludhiana vide order dated 14.09.2022. But the complainant vide letter dated 16.11.2022 has alleged non-compliance of the orders of the Bench by the First Appellate Authority, as such this request of appellant is treated as Second Appeal.
3. On the request of the Complainant, his complaint case has been converted into Appeal Case. Accordingly, the notice of hearing was issued to the parties for 31.05.2023.
4. The Appellant states that information sought has not been provided to him.
5. The Respondent states that information sought by the appellant is still under consideration before the ADCP-1, Ludhiana (Ms. Rupinder Kaur Saran, P.P.S.) and further requests that some more time be given him to provide the requisite information to the appellant.
